Minimum Admissions Requirements for Excel Middle School and High School Programs

Official High School Transcripts

Official High School Transcripts are required when transferring credits to Excel High School (EHS). Submit official transcripts to:

Age Requirements

- **Middle School Candidates:** Students entering 6th grade must be 11 years or older and have completed the 5th grade.
- **High School Candidates:** Students entering 9th grade must be 14 years or older and have completed the 8th grade.
- **Adult High School Program:** To enroll in the adult high school program, you must be 18 years or older and have not attended high school for at least six months.

Special Needs Programs

- Students who require special needs programs, such as IEP or Special Education (Title I or Title II) Services, should contact the EHS Counseling Office before enrollment.
- **Note:** As an online school, Excel High School is unable to support IEP/Special Education Services. However, there is ample room to be successful in this program.

Identification Requirement

- A current government-issued photo ID is required for final exams and graduation.

High School Curriculum Tracks

Excel High School offers six curriculum tracks to earn an accredited high school diploma, tailored to meet the diverse needs and goals of our students:

Standard High School Curriculum (Ages 14-18)

Designed for traditional high school students seeking a comprehensive education.

Honors Curriculum

For students seeking advanced coursework, this track offers a more rigorous academic challenge.

Advanced Placement Curriculum

Combines Advanced Placement (AP) courses with college-level coursework, providing an opportunity for students to earn college credits while in high school.

CA A-G Curriculum

A curriculum that meets the requirements for admission to the University of California (UC) and California State University (CSU) systems.

Adult High School Curriculum (Ages 18+)

Tailored for adults returning to complete their high school education, this track accommodates those who have been out of high school for a significant period.

- *Note: In order to be eligible for this program, a student must be out of standard high school for at least 6 months*

Summer School/Credit Recovery Courses (Age 14+)

Offers students the opportunity to catch up on credits, improve grades, or accelerate their education during the summer months or at any point during the school year

Each curriculum track is designed to provide a flexible and supportive learning environment, ensuring that students can achieve their educational objectives at their own pace.

Middle School Disclosure

(AGES 11-14 / GRADES 6-8)

Tuition Payment Options

Excel High School offers a comprehensive middle school program for grades 6 through 8 at a cost of \$1,690 per school year. Tuition can be paid in full at the beginning of the school year or through 10 interest-free monthly installments of \$169. Monthly installment payments must be set up on autopay and are due on a recurring monthly basis until the tuition is paid in full.

Early Termination/Cancellation

Should a student need to terminate their enrollment early, there is a cancellation fee of \$200. Please note that no refunds will be issued for any installment payments already made. To process a cancellation, a cancellation form must be submitted. Additionally, no records or transcripts will be provided until the early termination fee is paid.

Program Duration

Students have up to 12 months to complete each grade level. The entire middle school program (grades 6-8) must be completed within three years or less.

Extension Policy

If needed, a one-time, two-month extension per grade level is available at a cost of \$200.

Standard High School Disclosure

(AGES 14-18 / GRADES 9-12)

Tuition Payment Options

Excel High School charges \$1,900 for full-time enrollment per grade level for the standard, accredited high school courses (non-adult). The tuition covers up to six 2-semester courses. Payments for the standard high school can be made in full (\$1,900) per grade level or in 10 interest-free monthly installments of \$190. Monthly installment payments must be set up on autopay and are due on the monthly due date on a recurring basis until all payments are made in full. Students opting for the monthly installment plan must agree to the auto-pay debit requirement. Excel High School offers the standard high school program as one grade level (equivalent to two semesters).

Program Duration

Students have up to 12 months to complete each grade level. The entire traditional high school (non-adult) program must be completed within 48 months or less.

Early Termination/Cancellation

Should a student need to terminate their enrollment early, there is a cancellation fee of \$200. Please note that no refunds will be issued for any installment payments already made. To process a cancellation, a cancellation/drop request form must be submitted. Additionally, no records or transcripts will be provided until the early termination fee is paid.

Extension Policy

If needed, a one-time, two-month extension per grade level is available at a cost of \$200.

Optional Enhanced Service

The Success Coach Pro service, an optional enhanced dedicated success coaching service, is available for an additional \$1,000 per grade level, payable in four installments of \$250 each.

Honors High School Disclosure

(AGES 14-18 / GRADES 9-12)

Tuition Payment Options

Excel High School charges \$2,200 per grade level for the accredited Honors high school courses (non-adult). Tuition payments can be made in full (\$2,200) or through 10 interest-free monthly installments of \$220 per grade level. Monthly installment payments are auto-billed and are due on a recurring basis until the tuition is paid in full.

Program Duration

Each grade level consists of two semesters, and students have 12 months to complete each grade level.

Extension Policy

If needed, a one-time, two-month extension per grade level is available at a cost of \$200.

Early Termination/Cancellation

Should a student need to terminate their enrollment early, there is a cancellation fee of \$200. No refunds will be issued for any installment payments already made. To process a cancellation, a cancellation form must be submitted. Additionally, no records or transcripts will be provided until the early termination fee is paid.

AP High School Disclosure

(AGES 14-18 / GRADES 9-12)

Tuition Payment Options

Excel High School charges \$4,900 per grade level for the accredited AP high school courses (non-adult). Tuition payments can be made in full (\$4,900) or through 10 interest-free monthly installments of \$490 per grade level. Monthly installment payments are auto-billed and are due on a recurring basis until the tuition is paid in full.

Program Duration

Each grade level consists of two semesters, and students have 10 months to complete each grade level.

Extension Policy

If needed, a one-time, two-month extension per grade level is available at a cost of \$200.

Early Termination/Cancellation

Should a student need to terminate their enrollment early, there is a cancellation fee of \$200. No refunds will be issued for any installment payments already made. To process a cancellation, a cancellation form must be submitted. Additionally, no records or transcripts will be provided until the early termination fee is paid.

CA A-G High School Disclosure

(AGES 14-18 / GRADES 9-12)

Tuition Payment Options

Excel High School charges \$2,200 per grade level for the accredited CA A-G high school courses (non-adult). Tuition payments can be made in full (\$2,200) or through 10 interest-free monthly installments of \$220 per grade level. Monthly installment payments are auto-billed and are due on a recurring basis until the tuition is paid in full.

Program Duration

Each grade level consists of two semesters, and students have 12 months to complete each grade level.

Extension Policy

If needed, a one-time, two-month extension per grade level is available at a cost of \$200.

Early Termination/Cancellation

Should a student need to terminate their enrollment early, there is a cancellation fee of \$200. No refunds will be issued for any installment payments already made. To process a cancellation, a cancellation form must be submitted. Additionally, no records or transcripts will be provided until the early termination fee is paid.

Adult High School Disclosure

(AGES 18+ / OUT OF HIGH SCHOOL FOR 6 MONTHS / GRADES 9-12)

Tuition Payment Options

Excel High School charges \$99.00 per month for the accredited adult high school diploma program. The payment structure is \$99.00 per month for up to 10 months or less, depending on how many months it takes a student to successfully complete 21.5 credits and graduate. For example, if a student completes the program and graduates in 5 months, the total cost would be \$495.00 (\$99.00 x 5). This structure incentivizes quicker completion by reducing the overall cost for those who finish in less than 10 months.

Payments can be made in full (\$990) or through ten interest-free monthly installments of \$99.00 each. Payments are directly billed to the credit/debit card on file with the school. The program must be completed within 24 months, and students are expected to stay actively engaged in their courses.

Adult students may cancel at any time; however, there will be no refund of installment payments already made.

Re-Enrollment Policy

Should there be a need for re-enrollment due to non-cancellation, the requirements include one late payment, a late fee, and the current month's tuition, totaling \$208.00.

Extension Policy

If needed, a one-time, two-month extension per grade level is available at a cost of \$200.

Inactivity Policy

If a student has paid in full (\$990) but is locked out due to inactivity, the student may be subject to a re-enrollment fee of \$200.00, and courses may need to start over from the beginning.

Summer School / Credit Recovery Disclosure

(AGES 14+)

Course Fees

\$399 each for either a one-semester or two-semester course.

Program Duration

Students have up to 6 months from the date of enrollment to complete the course and students can take a maximum of 3 courses at a time.

Extension Policy

If needed, a one-time, two-month extension per grade level is available at a cost of \$200.

Early Termination/Cancellation

No refunds will be issued after 10 calendar days from the date of purchase.

Tuition, Fees, and Payments

Auto Payment Requirement

As per the enrollment agreement, tuition is auto-billed to the credit/debit card on file each month unless paid in full upon enrollment. Participation in the auto-billing option is mandatory to remain enrolled at Excel High School unless tuition is paid in full upon enrollment.

Past Due Accounts

Accounts two installments past due are subject to termination and may be sent to a licensed collections agency.

Chargebacks

Student accounts with a bank dispute (chargebacks) will incur a \$50 fee per chargeback, plus collection fees, and the account may be sent to collections. Accounts with chargebacks are not eligible for an installment plan with Excel High School, and any outstanding tuition will be due in full. Chargebacks may also make students ineligible for future enrollment.

Tuition, Fees, and Payments

Standard High School Diploma Program

The standard high school diploma program consists of two semesters per grade level, with an optional summer semester. Each semester includes 5 or 6 courses of 0.5 or 1.0 credit each, for a total of 21.5 to 24 credits needed to graduate. The stated price includes all registration and admission fees and can be paid in full or per month. These fees are non-refundable after 10 calendar days from the date of enrollment.

Estimated Total Program Price

Adult Students

If an adult student completes their entire diploma with Excel High School, the total program cost will be \$990 or less, including tuition, registration, and other fees, provided the student remains actively engaged in the program, making progress, and earning credits. If a student is paid in full (\$990) and locked out for inactivity, they will be subject to a \$200 re-enrollment fee, and courses may start over from the beginning.

Traditional Standard High School Students (Non-Adult)

If a student completes their entire grade 9–12 standard diploma with Excel High School, the estimated 4-year program cost will be \$7,600, including tuition and all fees. The total program cost may be less depending on transfer credits, the selected program, and potential tuition, fee, and other charge changes at Excel's discretion. Costs may also be reduced by transfer credits and other promotions and discounts.

Additional Fees & Policies

NSF Fee

For any check, draft, or money order returned for insufficient funds (NSF), a \$50 fee will be charged, and Excel High School will resubmit for payment.

Chargeback Fee

Chargebacks are subject to a \$50 bank fee per transaction.

Auto Payment Requirement

Students must use the Auto Payment option and are responsible for keeping account information up to date to avoid any late or returned payment penalties.

Default Payments

For any default not cleared within 10 days of notification of non-payment, Excel reserves the right to discontinue services, add any collection and/or attorney's fees, and the student will not be entitled to any refunds or re-enrollment.

International Students

Students in Canada and other foreign countries are responsible for any applicable customs duties and additional shipping fees. Payments must be made in U.S. dollars only.

Early Termination/Cancellation

Early termination/cancellation may be subject to a \$200 cancellation fee, with no refunds for installment payments already made.

Payment Delinquency Policy

Past due student accounts that have not received payments for 60 days may be referred to collections.

Diplomas and Transcript Policy

Diplomas and transcripts will be held until all tuition fees are paid in full.

Late Payments

If your monthly payment is late by 4 days or more, a late fee of \$10.00 will be charged. Accounts past due 4+ days will be placed on lockout status. If the overdue amount and late fee are not paid within 30 days, Excel High School reserves the right to suspend your enrollment in the program immediately and require you to pay the outstanding balance of the program price associated with the payment plan you chose. Additionally, you will be responsible for any collection costs, including legal fees, incurred by Excel High School to collect the amounts owed.

Diploma Completion Time

Standard/Honors (Non-Adult) Program

The standard and honors high school diploma programs can typically be completed in about 2-4 years, with 6-8 months allocated per grade level. Students have a maximum of four (4) years from the date of enrollment to complete their program, with up to 12 months allowed per grade level.

Adult Fast Track Diploma

The adult high school fast track diploma program can be completed in 12-18 months or sooner with transfer credits. Adults have a maximum of 24 months to successfully complete the program.

Transfer of Credits

Students may be eligible to receive up to 16 transfer credits for high school courses completed at an accredited institution. Acceptance of transfer credits is determined by the receiving institution.

Upon graduation, students will be awarded an official, accredited high school diploma. No assurance is made of eligibility for job placement.

Accreditation & Credit Transfer

Excel High School is a regionally accredited institution. Most credits from Excel High School are accepted by public and private high schools, colleges, universities, employers, and the United States Military. However, acceptance for transfer of academic credits is ultimately determined by the receiving institution.

Cancellation & Refund Policy

Standard students can cancel or withdraw from Excel High School by completing the Cancellation Form available on the school's website. Adult students may cancel by speaking to a member of the school staff, using the Learn Stage Help Desk, or by submitting a written request via US Mail.

Excel High School reserves the right to administratively cancel any student who fails to demonstrate satisfactory progress toward their grade level completion or high school diploma. Academic dishonesty or other violations of the High School Catalog may also result in disciplinary action up to and including the termination of your enrollment.

Notice: Any holder of this consumer installment contract is subject to all claims and defenses which the debtor could assert against the seller of goods or services obtained pursuant hereto or with the proceeds hereof. Recovery hereunder by the debtor shall not exceed amounts paid by the debtor hereunder.

Dispute Resolution

Any controversy or claim arising out of relating to this Agreement, or breach thereof, no matter how pleased or styled, shall be settled by arbitration in accordance with the Commercial Rules of the American Arbitration Association and judgment upon the award rendered by the Arbitrator may be entered in any court having jurisdiction. In no event shall Excel High School be liable for any incidental, consequential, punitive, or multiple damages of any kind. Any arbitration or other legal proceedings of any kind related to this Agreement or your enrollment with Excel High School shall be conducted in Hennepin County, Minnesota, and by signing this Agreement you consent to the jurisdiction of the State or Federal Courts sitting in Hennepin County, Minnesota and to holding all arbitration proceedings in Hennepin County, Minnesota.
